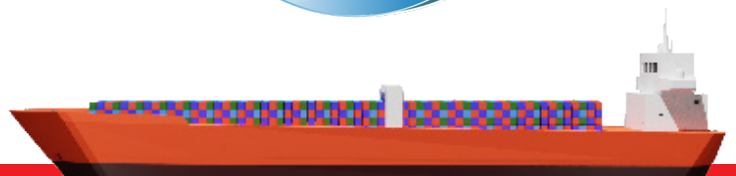

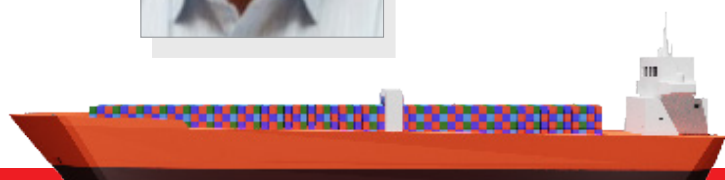

He was the General Manager of Bank of China Limited London Branch & the Chief Executive Officer of Bank of China (UK) Limited from 2011 to 2015. Mr. Fang joined Bank of China Head Office in 1996. Educated at Beijing Foreign Studies University in China to postgraduate level, Mr. Fang also received his MBA with Distinction from University of Hertfordshire, UK in 1996. He has been a CFA Charter Holder since 2007.

Stephen Perry

Stephen Perry is the Chairman of The 48 Group Club, a British business association committed to promoting China-UK economic cooperation and positive bilateral relations. Stephen has over 50 years' experience of doing business with China. He is a recipient of the China Reform Friendship Medal, presented to him by President Xi Jinping at the ceremony marking the 40th anniversary of China's reform and opening-up.

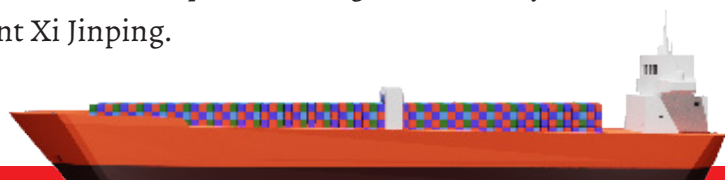
Perry is one of the select group of people who played a decisive role in breaking the ice in the two major countries' trade relations and he is a lifetime contributor to bridging the gap and building ties between China and the Western world.

In July 1953, Stephen's father Jack Perry, founder of the London Export Corporation, led the historic Icebreaker Mission to Beijing. This led directly to the formation of The 48 Group as the very first organisation with a singular focus on promoting trade between the Western world and New China. The group had to overcome numerous obstacles, due not least to the US-initiated and led trade embargo, but it remained true to its mission.

Stephen first visited China in 1972, when our two countries established full diplomatic relations at ambassadorial level. He, together with his father, then helped seal the first trade deal between the USA and China, involving selling a range of US products, including polyester, agricultural chemicals and cotton.

Nearly seven decades after the original "ice-breaking" mission, The 48 Group Club, led by Stephen Perry, continues its efforts to promote China-UK relations. The club now has over 600 British and Chinese members, including leaders from corporate organisations, high-level politicians, diplomats, academics and groups focusing on cultural exchanges. The club organises meetings on a regular basis on China-UK relations and related issues, and its work embraces Britain, Europe and the US.

As an outspoken, experienced and thoughtful friend of China, Perry often appears on TV and other media to share his understanding of China and its increasing global impact. He speaks highly of China's Belt and Road Initiative and the concept of building a community with a shared future for humanity advanced by President Xi Jinping.

Sir Sherard has been at HSBC since 2013, working as Senior Adviser to the Group Chairman and Group Chief Executive, and more recently heading the Group's global government and public affairs functions. He also chairs HSBC Bank Oman. Earlier he spent over 30 years in the British Diplomatic Service, finishing his career as Ambassador to Israel, Saudi Arabia and then Afghanistan.

Sir Sherard is Chair of the China-Britain Business Council, the Saudi British Joint Business Council, and the Omani British Business Council; Honorary Vice President of the UK Financial Inclusion Commission; an Ambassador for the Money Advice Trust, and for the Winston Churchill Memorial Trust; a Committee Member of The Hong Kong Association; and a Board Member of Asia House. He is the author of two books: *Cables from Kabul* and *Ever the Diplomat*.

Lord O'Neill is a cross bench peer in the House of Lords. He is a member of the panel of Senior Advisors to Chatham House. Jim recently became Chair of Northern Gritstone. His previous roles include, joint head of research at Goldman Sachs (1995–2000), its chief economist (2001–10) and chairman of its asset management division (2010–13); creator of the acronym BRIC; chair of the City Growth Commission (2014); chair of the Review on Antimicrobial Resistance [AMR] (2014-16); commercial secretary to the Treasury (2015-16). He is a board member, and one of the founding trustees of educational charity SHINE.

Lord O'Neill was created a life peer in 2015 and serves as a crossbench member of the House of Lords. He is an honorary professor of economics, University of Manchester, and holds honorary degrees from the University of Sheffield, University of Manchester, University of London and from City University London. He received his PhD from the University of Surrey and is now a Visiting Professor there.

Serial technology entrepreneur Andrew Bissell founded Sunamp in 2005 to develop an affordable and sustainable solution for heat energy storage for commercial and domestic markets. He led one of the most exciting academic and industry partnerships in Scotland, teaming up with the University of Edinburgh to develop the unique heat energy storage phase-change material which is the core patented technology delivering high powered heating and cooling in Sunamp thermal batteries. Up to four times smaller than traditional hot water cylinders, Sunamp products are key to optimising renewables. Andrew is Sunamp's visionary and drives the senior management team in setting strategy and extending Sunamp's product and technology lead. The company is currently active in 17 countries world-wide.

Based in London, Roger is a senior Director of RSK's core business, working across their main markets in Africa and the Middle East, including high growth regions, such as Neom in Saudi Arabia.

His background is in the real estate investment business, training at Jones Land LaSalle's Head Quarters in London as partner lead for National Investment, and then on to fund management roles with LaSalle Investment Management.

A strong interest in the environmental sector took him into building up his own company which he sold to RSK, one of the world's largest environmental consulting businesses with a turnover in excess of \$1 billion.

His work now includes forming consortia to develop strategic infrastructure assets whilst also managing high profile consultancy appointments such as Neom's Environmental Auditor.

RSK's offering in the environmental sector provides an excellent viewpoint from which to assess Levelling Up progress. The core business of providing detailed Environmental and Social Impact Assessments is the starting point for most new schemes, whether part of a Renewable Energy development or inner city regeneration scheme, where remediation, for instance might be necessary. But our scope includes downstream environmental monitoring such as air quality, noise and the natural habitat.

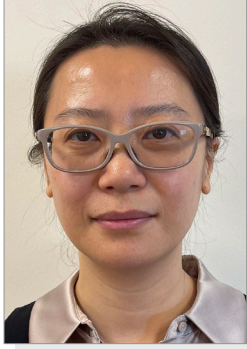


Dr. Li Yao

He firmly believes that with increasing smart devices and data becoming available in the energy sector, AI combined with innovative business models will reshape this industry. Starting from scratch, Carol successfully led the UK branch to reach the £10 million mark of turnover within 3 years. Power Link UK is striving to providing high end back-up power and prime power generators to its wide ranging customers.

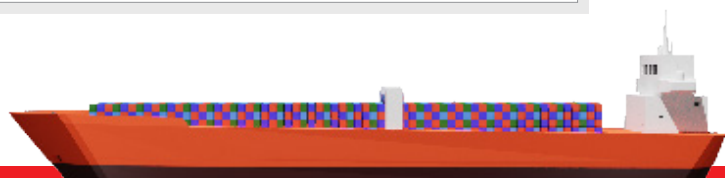

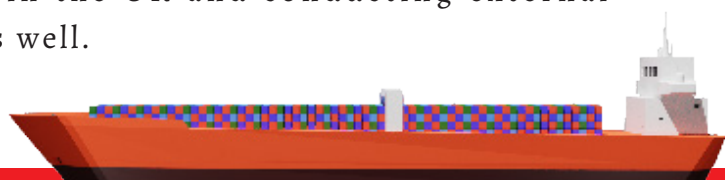

China Chamber of Commerce in the UK (CCCUK) was founded in 2001 (previously known as the China Enterprises Association in Britain), mainly consists of Chinese enterprises in the UK and Chinese economic and trade organisations. The CCCUK is a non-profit organisation representing and serving interests of Chinese enterprises, aiming to promote China-UK economic and trade relations.

In September 2015, China Enterprises Association in Britain was renamed as the China Chamber of Commerce in the UK. The CCCUK aims to establish close relations with UK government departments, companies, and business associations, to promote China-UK cooperation and communication, assisting the establishment and future growth of Chinese enterprises in the UK.

At present, the CCCUK has nearly 300 corporate members, covering dozens of sectors, including finance, technology, telecommunications, energy products, real estate construction, trade, etc. The CCCUK has a Standing Committee with 27 corporate members and five subordinate committees including Financial Committee, Technology Committee, Supervisory and Management Committee, Energy Committee, and Infrastructure and Trade Committee. With support from the Chinese Embassy in the UK, the CCCUK has grown into an important force representing business interests of Chinese enterprises in the UK and conducting external exchanges as well.
